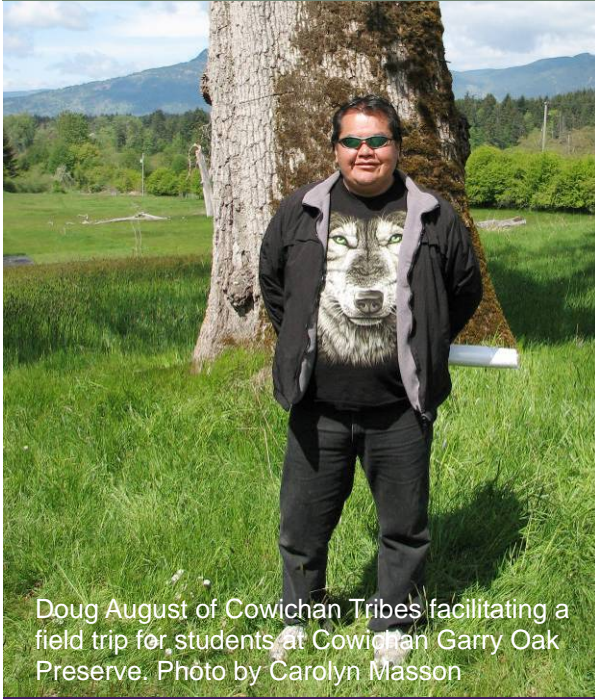


## What's Next? Some of GOERT's projects for 2010-2011

Releasing the *2010-2016 Recovery Strategy for Garry Oak and Associated Ecosystems and their Associated Species at Risk in Canada* and completing our new publication, the *Compendium of Garry Oak Ecosystems Restoration*

Increasing capacity to develop more species at risk recovery strategies and action plans and to provide more assistance to partners, including conservancies, local governments and First Nations

Updating and adding to Catalogue of Site Records and providing information on priority Garry oak and associated ecosystem sites to partners

Restoring habitat at priority sites with species at risk to protect populations and minimize threats

Increasing public awareness of the value of Garry oak habitat and species at risk

## Our unique strategy

GOERT's recovery strategy uses a unique, ecosystem-based approach to protecting individual species at risk. Recovery planning in Canada has historically taken a species-by-species approach, but national initiatives now recognize the importance of incorporating a wider scope in some circumstances.

The ecosystem-based approach makes sense in this case, as so many species at risk occur in the same geographical area in Garry oak and associated ecosystems.

## Like an ecosystem

Like an ecosystem, GOERT functions through relationships. Thanks to the dedicated work of individuals from the community, non-profit groups, businesses, and all levels of government, we have achieved much toward protecting Garry oak ecosystems and species at risk for the future. In 2009-10, approximately 80 individuals contributed their time and expertise to the Team or one of its working groups.

## Highlights for the 2009-2010 year

### Recovery planning for species and ecosystems at risk

In partnership with the Ministry of Environment, Parks Canada and many local governments, we conducted rare plant surveys for 15 species at more than 40 sites.

Information from rare plant surveys was incorporated into recovery planning documents and provided to landholders to help guide management efforts.

Worked with land trusts, conservancies, and staff from the Ministry of Environment and Parks Canada to ensure that landholder contact for species at risk is coordinated and effective.

### Landholder contact

Provided more than 70 private landholders with technical advice, information, and assistance, enabling them to protect and restore the Garry oak and associated ecosystems and the at-risk species they sustain on their property.

Established 7 verbal stewardship agreements with landholders and developed habitat steward signs for landholders.

Established a Planning and Development Working Group to provide expert advice on how to best protect Garry oak ecosystems and species at risk through planning and development processes.

### Stewardship for species at risk

In 2009-2010, GOERT established a new stewardship program at one site, and continued to lead stewardship at an additional 8 sites. We:

- ❖ monitored sites and species at risk populations
- ❖ developed and updated restoration plans
- ❖ conducted restoration treatments specifically targeted at reducing or eliminating the threats posed to species at risk by invasive exotic shrubs, herbivory and inappropriate land use

## More Highlights

### Communications and Outreach

Held our annual Research Colloquium, drawing nearly 100 participants from BC, ON, WA and OR. Proceedings are available at [www.goert.ca/research](http://www.goert.ca/research).

Held a native plant workshop for the "green thumb" trade, including development industry representatives, golf course and university groundskeepers, landowners, conservation groups and consultants.

Held 8 seminars, workshops and meetings with local governments and First Nations, including a workshop and field trip for Cowichan Tribes (see [www.goert.ca/news/cowichan-tribes](http://www.goert.ca/news/cowichan-tribes)). Meetings or seminars were also held with Beecher Bay First Nation, City of Victoria, Islands Trust, City of Nanaimo, and the District of North Cowichan.

Provided information at more than 20 other workshops, site visits, meetings, conferences and events.

Distributed 400 brochures, 3500 flyers, and 4450 *Garry Oak Gardener's Handbooks*.

There were 26,000 downloads of resources from our website.

### New publications and resources

New pages were added to our species at risk field manual for the following 4 species: *Lupinus oreganus* ssp. *kincaidii*, *Carex tumulicola*, *Lasthenia glaberrima*, and *Uropappus lindleyi*.

New pages were added to our invasive species field manual for the following 6 species: *Alliaria petiolata*, *Centaurea biebersteinii* & *C. nigra*, *Senecio jacobaea* & *S. vulgaris* and *Soliva sessilis*.

Held a workshop to gather input on the development of our *Compendium of Garry Oak Ecosystems Restoration* (to be completed summer of 2011).
